

Be Steadfast In Prayer by Nancy E. Cole, Prayer Posse Director

Some time ago, as I was pouring over the passage in the Bible of Daniel 10, I was struck by its relevance to an experience that one of our past mission teams encountered while ministering in Peru. Daniel 10 shares the account of Daniel's dealings (though unbeknown to him at the time) with what are now commonly referred to as "territorial spirits" or spirits which work in specific areas to bring darkness and destruction to the people groups occupying those regions.

Daniel is burdened by a vision which is not entirely clear to him. Wrestling steadfastly in prayer and fasting for a three week period to better understand this vision, Daniel is then confronted by a heavenly being who describes himself as having come in answer to his prayer vigil. Verse 12 reads, "Do not be afraid, Daniel. Since the first day that you

March 2008 Team Prepares for a Journey in Faith by Lisa K. Schroder, Mission Director


Once again a team of volunteers prepared to travel for orthopaedic medical ministry has been masterfully assembled in a fashion only God could imagine. On March 15, 2008, individual team members and family "clans" will set out from 5 different US cities, as well as from the capital city of Lima, Peru, to land ultimately in the impoverished, yet bustling, jungle town of Pucallpa.

Our team includes first time US members: Dr. Kydee Sheetz, Adlai Cole, Kyle Schroder, and Justin Schroder and "repeaters": Chad Robran (3 prior trips), the Cole family (too many to count!), and Lisa and Jacob Schroder (2 prior trips). In addition, we will again be joined by our Peruvian friends and healthcare associates, Dra. Rosita Escudero and Dr. Jose Paredes.

Of note, Dr. Kydee Sheetz, an orthopaedic surgeon practicing in Duluth, Minnesota, contacted us as recently as January in what seemed to be yet another connection which could only have been divinely orchestrated. You see, every March for the last several years Dr. Sheetz has volunteered with World Medical Mission in Kenya, Africa. Due to the political unrest there, this year's trip had to be cancelled, but Kydee's heart for volunteering in orthopaedic medical missions was not deterred. She began to seek other opportunities for March 2008. Amazingly, our trip was planned at the exact time which overlapped with her original volunteer plans!

Experience has taught some of our team members to expect the unexpected. Individual assignments are often unknown. The twists and turns of the trip that lie ahead are hidden to us now. The magnificent ways in which God may mold us as individuals and use us as His instruments can only be imagined with youthful excitement. Yet, by packing our bags with strong faith in our Sovereign Lord, a loving heart for sharing the Gospel of Christ, and willing hands for performing any task which is asked of us, we know that God will provide purpose and protection throughout the successes and the challenges encountered on the trip.

Across time it has become amazingly clear to us that despite language and cultural differences between the Indians and ourselves, we're actually more alike than one would think possible, particularly as it relates to common sporting interests. Boys must simply be boys, wherever they happen to grow up!! Our mothers probably could have told us that now, couldn't they?

While David and Alfredo have to live in town (the city of "Pucallpa") away from family during the school week due to their inability to afford daily transportation back to their jungle abode ("Cashibo"), the way they spend their weekend leisure/recreational time at home looks strikingly similar to the way we spend ours...fishing, competitive sports, doing odd jobs, and simply "hanging out."

Perhaps we derive most enjoyment from our Indian friends in anticipation of the exchanges we make at the beginning and ending of each of our trips to Peru.

The boys give us jewelry made by their sisters, beads, fish teeth, alligator scales, monkey bones, and in return, we give them interesting foods, clothing, and athletic gear that they're otherwise unable to obtain. At age 7, it seems like a bargain to me...at age 13 it seems like a deal to my brother...whatever your age, we bet

you'd like to get in on the action as well! Consider yourself invited to come on down.

set your mind to gain understanding and to humble yourself before your God, your words WERE HEARD, and I have come IN RESPONSE TO THEM." God's messenger goes on to relay to Daniel that he was detained twenty-one days in coming (the exact number of days Daniel had been making appeals to his heavenly Father), due to opposition he faced by another supernatural being who was opposed to the things of God. Two demonic spirits, in fact, are mentioned in this passage as having to be contended with; it appears that Satan has appointed them, this time around, to suppress the truth of God's work in the specific territories of Persia and Greece.

Certainly the New Testament attests to these demons as well, in verses such as I Thess. 2:18 where specific missionary activity is thwarted ("For we wanted to come to you-certainly I, Paul, did, again and again-but Satan stopped us.") and 2 Cor.4:4 ("The god of this age has blinded the minds of unbelievers, so that they cannot see the light of the gospel of the glory of Christ, who is the image of God."), to name a few.

The reality of this behind-the-scene's warfare needs to serve, at the very least, as a prayer catalyst for us, especially in undertaking ministry to lands and people groups (such as Peru and native Indians therein) who may be just as deeply steeped in spiritual strongholds as those highlighted in the Biblical references above. Towards this end, permit me to share a succinct vignette attesting to God's having HEARD and RESPONDED TO very specific intercession by a friend on behalf of our team during one mission trip to Peru.

Our medical team was six days into our mission, when I sensed, in a very graphic manner, the reality of spiritual darkness working at odds against our efforts to bring hope and healing to the Peruvian people. Little did I know that on the exact day that our team faced some relatively tense moments with the tribal council of one of the villages we were visiting, a beloved friend and prayer warrior in the Lord (some 1500 miles away) had awoken early that particular morning to pray for us. She describes herself as having been moved, the entire day through, to continually lift us before the throne of Grace and call upon the Lord's name that He might enfold us with His "hedge of protective mercy." The riveting of her spirit for a day's time sent her on a prayer trajectory for a very specific 12-15 hour period. I profoundly believe that these pleadings (that we might be surrounded by a bulwark of defense) also served to rescue us that very same evening from a potentially serious explosion with our mission base camp gas stove.


How gracious of our Lord to hear the appeals of his saint in Minnesota in the very moment we needed such specific intercession for safety in the remote parts of Peru. How God moved our friend and stirred her heart keenly to pray fervently for such a time as that is but a marvelous testimony to His sovereignty in and through and over all things. Brushes with harm—yes; evil fingers laid upon us—no! A striving to interrupt our mission focus during that short-term trip and thus keep the book of truth from being known and believed—ves:



anxiety that the enemy was stronger than our Jesus—absolutely not!!

Although Eph.6:12 has always been of particular intrigue with its call to believers regarding the necessity of a spiritual warfare mindset, I have never been as personally awakened to the spiritual reality of "evil spirits, dark principalities, or powers in the heavenly places" as I was last May. In view of the realization that such supernatural influence may exist in the Peruvian culture, and that the Devil may be in the business of creating corruption and blindness such as is described in Daniel, I began asking myself how Scalpel At The Cross might do ministry in such a territory as this? Daniel 10 serves to remind and passionately convict me, as never before, of the necessity of fervent prayer cover. Growing up in the states has tended to shape my Biblical world view so that it fits "cleanly" with more natural (rather than supernatural) ways of thinking about the world. Thanks to reflection on Daniel 10, I feel more equipped to interpret incidents through the lens of extraordinary as well as ordinary means.

Oh that we as a people greatly loved by the Redeemer might purpose to wrestle in the prayer realm while warfare is waged in the spirit realm. The battle, in essence, is in knowing God and the power of the Holy Spirit and in being armed with promises of Christ's authority about our stature as children of God. May we covet to pray in the manner that Daniel did.



Dear Friends of the Mission,

I thought you would be interested to hear that I recently travelled back to Lima. A whirlwind 10-lecture/48-hour tour to their orthopaedic academy meeting....and out! But, I had a great time. The people were fabulous and so grateful. Peru is so dear and was wonderful. I stayed across from "Larco Mar," a beautiful shopping and dining plaza overlooking the Pacific Ocean in Lima, but I only had one brief dinner there on the cliffs during my stay.

There were 500 doctors from all around Peru (making up most of the orthopaedists in the country!), and, wouldn't you know, Dr. Paredes, our close orthopaedic surgeon-friend and co-laborer from Pucallpa, was in the front row for every talk. He was so proud, I think, to be associated with the mission and all of us... particularly as I incorporated *Scalpel At The Cross* into a number of my talks, including the Presidential Guest Lecture in which I gave a brief talk on the ministry and the meaning of the name, *Scalpel At The Cross*. Many, many interested doctors!

There is a tight knit group of traumatologists in Lima that offered everything from staffing support at Hospital de Pucallpa to joining us for trips when we go. This is a wonderful and extraordinary core of people. Some of them are very talented and are good references in the case that we or our missionary friends have orthopaedic trouble while in Peru.

One night in Lima, Dr. Paredes took me on a tour of his hospital in Lima, where he now works, Hospital de Emergencias, which was full of earthquake victims. His boss, the Jefe (Chief of Surgery), Dr. Juan Cangalya, is an exceptional human being, very interested and helpful.

Dr. Paredes and I got to share some Chifa (a Peruvian-Chinese Cuisine) after the hospital tour, and I was able to share the gospel with him. He is starting to recognize the difference between religion and a personal relationship with Christ. He wants to go to Pastor Brian VanderKodde's church when he is in Lima and to the mil Palmeras church when he is in Pucallpa. I thought that was great. Jose has moved to Lima temporarily, but seems unsettled as to how long he will stay based on the health of his daughter. He stated and restated that he would travel to Pucallpa with us whenever we go.

I'll anxiously wait to see how the Lord might use these willing hands and hearts to expand the reach of the mission in Peru!
